Maintenance Calculation

1. 40% of higher-income parent's AGI (monthly)	<u>6,020</u>
2. 50% of lower-income parent's AGI (monthly)	<u>2,163</u>
3. Line 1 - line 2	<u>3,857</u>
4. 40% of both parties' combined adjusted gross incomes	<u>7,750</u>
5. Gross income of lower-income party	<u>4,326</u>
6. Line 4 - line 5	<u>3,424</u>
7. Maintenance (smaller of line 3 or line 6) (monthly)	<u>3,424</u>

Maintenance - Duration

Duration Calculation

1. Date married. 3/7/1998
2. Date of decree or the date of the hearing on disposition
of property (whichever is earlier). 4/5/2014
3. Number of full months of marriage. 192
Total number of months of marriage is between 36 and 240. Duration is specified in statute.
4. Duration of maintenance under statute. 8 years and 0 months
